



This agreement (the "Agreement") made as of this day of _____, 2009 by and between Goat Denim Clothing Co. [A subsidiary company of Day & Brabene Enterprises], whose address is 150 Luther St., Ashland, OH 44805 ("Company"), and _____ ("Band").

Term and Territory: The term of this Agreement shall commence on the date first set forth above and, unless terminated earlier as permitted hereunder, will end twelve (12) months thereafter ("Term"). The territory of this Agreement shall mean solely the United States, its territories and possessions.

(1) Band Obligations:

(a) Band agrees to display at least one promotional banner, or logo (If logo, logo will be chosen by Company) on its official MySpace page (if applicable) and official web site (if applicable) for the entire Term. Band agrees to link banner, or logo directly to the Company's Site (www.GoatDenimClothing.com) for the entire Term.

(b) Band must reserve a spot in their top friends (Myspace, if applicable) for our official Company profile. Our Company profile must maintain a spot for the entire length of the term.

(c) Band agrees to promote and wear provided garments to their shows, tours, events, around town, etc. Pictorial proof will be provided after specific events determined by Band. Photos (Non Promotional) proving the Band is wearing the provided garments must be provided within 60 days of sign on and every 90 days thereon. (Non professional photography is accepted)

(d) Company will periodically send Band, Company coupons, stickers and other promotional material for Band to put on Band's merch table and for Band to pass out to people at shows, tours and other events and also around Band's home town.

(e) Anything Company deems necessary, or creates/thinks up in the future that is reasonable and in good taste. Ideas from Band are welcome as well.

(2) Band Photography Obligation:

(a) Band agrees to take promotional pictures with the provided merchandise (Either free, or discounted) from Company within 4 weeks of being postmarked. Band hereby understands either I, or as a Band will provide payment in full, for the photo shoot and or photographer. Company is in no way responsible for payment of the photo shoot. Nor will Company book the photo shoot, or provide the photographer.

(b) Band will provide 5 (Five) high resolution images (High Resolution is 300 dpi+ at or around 10" in width, or height) to Company to be used for web, print, or any other type of digital media, or promotion. Band hereby gives Company the right to use, print, promote, or reproduce these pictures in any way shape or form, for any reason Company deems necessary without prior consent to the photographer, or band.

(c) Band agrees there will be at least three (3) members, (If applicable) or two thirds (2/3) of the band wearing the provided merchandise in the photo shoot and in the final set of photos.

(3) Company Obligation Outline:

(a) Company **does not guarantee**, but may provide Band with co-op advertising. (Both company and Band are featured together) Ex. Coupons, flyers, colab T-shirts, web, or print advertising, etc. Band and Company are entitled to work together to determine: Costs (if applicable) circulation and other necessary details for co-op partnership.

(b) Company agrees to display one text link, linked to official Band's Myspace page for four (4) weeks on Company's official Myspace page. When Company receives Band's promotional pictures (As stated above, see 2a) text link will then be switched out with photo link, linking to the Band's official Myspace page, or web site if applicable.

(c) Company **does not guarantee**, but may provide Band with a top friend spot in the official Company Myspace profile, including official street team profiles for an indefinite time period.

(d) Company can provide any of the following services for Band at discounted prices: Screen Printing, Digital Printing, Graphic Design, Apparel Design, Web Design, Web Development, Web Hosting, Myspace/Twitter Promotion, Photography and Cinematography, all for a pre determined price between Company and Band.

(e) Company agrees to add Band's promotional picture and official logo to a pre determined spot on the official Company web site.

(f) Company **does not guarantee**, but may be entitled to book Band in, or around Central Ohio. (Only if Band chooses to accept. Ex. Greater Cleveland, Columbus, Canton, Akron, etc.) Payment per booked show fluctuates and will be pre determined between Company's partner booking agency and Band. Band can refuse booking service if chosen too.

(g) Anything Company deems necessary, or creates/thinks up in the future that is reasonable and in good taste. Ideas from Band are welcome.
